Dear BOCES State Aid Designees:

This is to inform you of a new data item that will need to be added to the XML files uploaded by BOCES to SAMS in the upcoming claim cycle. The change is explained below and affects only the BOC_MISC_DED_DATA form/data area in SAMS.

*Actual and projected year amounts for this new item should be submitted **only** for the 001 (Admin) Coser using only the 1000 State Activity Code.*

About the new data item:

The description of the new item is:

Other Post-employment Benefits (OPEB) Included in Sch 4 Admin Expense

OPEB are supplemental retirement benefits, other than pension, which may include such things as health insurance and dental, vision or prescription benefits.

This data item will be added as item number 6 in the BOC_MISC_DED_DATA schema area and on the SAMS Miscellaneous Deduction Form.

The new XML schema items will be named:

boc_opeb_act
boc_opeb_proj

Explanation for this change:

The calculation of aidable BOCES Admin (001) expense includes the calculation of net administrative expense in excess of 10% of total service and admin expense. The greater of a) total admin expense in excess of 10% of total expense, or b) the excess salary amount for the 001 Admin Coser, is deducted from BOCES admin expense before allocation to components.

Total expense in the Admin (001) Coser on Schedule 4 of the SA-111 should include all 'other postemployment benefit' costs (OPEB) for the entire organization. Beginning with 2014-15 SAMS, SED will collect the OPEB portion of total admin expense so it can be excluded from the total administrative expense used to calculate the 10% admin cap described above. Only BOCES that correctly include OPEB in Schedule 4 Admin (001) expense should report data in the new item. SED will adjust the calculation in the Administrative Expenditure Check section of the SAMS BOC-AD and BOC-AD EST reports so that administrative expense excluding reported OPEB costs is used in calculating the deduct.

For some BOCES this change will result in a higher administrative expense for allocation across components, displayed at item #42 on SAMS BOC-AD and BOC-AD EST reports, than would otherwise be calculated.

About the BOC_MISC_DED_DATA schema area / SAMS form:

The existing BOC_MISC_DED_DATA schema area contains five BOCES level data items, requires actual and projected data and requires that if applicable the cross contract provider BEDS code be included for any record associated with a purchased rather than provided Coser. However, OPEB will never be reported as a cross contracted service.


A SAMS form displaying data reported for any of these items can be viewed in SAMS by individual service by clicking on BOCES Financial from the BOCES SAMS main menu bar, then State Aid Forms, Official or Revision, then Miscellaneous Deductions from the menu tree, and selecting a service from either the provided service or purchased service drop down menu.
